### Director's Notes

Encore. Service. Excellence. These powerful words reflect the mission of the Retirement Center and the continuing contribution of retirees to the University and to the larger community. As your new Retirement Center Director, I am honored to serve you in promoting our mission of programs and services that contribute to your wellbeing and creativity and support your beloved University.

We live in exciting and challenging times. Especially with the aging of Baby Boomers, individuals born between 1946 and 1964, visions for longer lives are in flux. New definitions of the possibilities and meaning of longer lives and “retirement” are gaining traction. UC Berkeley Professor, Marian Diamond, captured this movement with her expressed dislike for the term “retirement” as suggesting a period of resignation and departure from life. She proposes the term “redirection”—a time to rediscover or move in a different direction, and continue to surround ourselves with stimuli to fulfill our later years. Gene D. Cohen, M.D., Ph.D. has expanded our concepts for later life with his writings on human development in the second half of life. Dr. Cohen is the first Director of the Center on Aging, Health & Humanities at George Washington University and past Acting Director of the National Institute on Aging. He has expanded Erik Erikson's brief description of aging in Identity in the Life Cycle to four overlapping late life development stages: 1) Midlife Reevaluation Phase—Where have I been? Where am I now? Where am

I going? 2) Liberation Phase—a period of time to experiment and to innovate, 3) Summing-Up Phase—a period for life review, conflict resolution and social contribution, and 4) Encore Phase—a period of reflection and desire for continuation and celebration. #### **Economic Challenges For the New Administration**

*Organized by Professor John M. Letiche of the Department of Economics*

Due to the early scheduling, the first course of the semester was announced by email and post card.

Nobel laureate Lawrence R. Klein and Professors Barry Eichengreen, John Quigley and Maurice Obsterfeld presented four separate lectures on the two facets facing the Obama Administration: The necessary measures to stimulate American economy to prevent sluggish long-term economic growth rates and the challenges facing the American economy in the global recession.

#### **Issues and Challenges in Our Food System**

*Organized by Dr. Jerry Siebert, Emeritus, Department of Agriculture and Resource Economics and Policy*

Four presentations will focus on different issues in the food system supply chain. The first will provide an overview of the global food supply and demand situation and identify some of the critical issues in the global food system. This presentation will be followed by three others focusing on food health and safety, nutrition, and water.

#### **Invasion of North America By Exotic Species: Is There Hope For the Future?**

This three session course considers the impact of human transport of exotic insects and pathogens that threaten human health and the productivity of agriculture and forests in North America and change forever our natural ecosystems.

### Long-Term Care Insurance: Is It Right For You?

Wednesday April 15 2pm–4pm

The Health Insurance Counseling and Advocacy Program (HICAP) provides unbiased professional information and assistance about Medicare and related health insurance products and is state-funded.

Making a decision to buy long-term care insurance (LTCI) takes careful research. Should I buy LTCI? What is the best LTCI policy? What is the best company to buy from? What is the right age to buy LTCI?

These sessions explain long term care and options for its financing while focusing on the features and the pros and cons of long term care insurance. The sessions also include information about available products and how they differ and offer guidelines for deciding whether or not to purchase a LTC insurance policy. ## On Campus and Around Campus

### CALcierge Office

The campus recently started the CALcierge service to assist with faculty recruitment and retention under the auspices of the Vice Provost for Academic Affairs and Faculty Welfare. CALcierge was created to increase UC Berkeley's ability to recruit and retain faculty by offering assistance to new faculty during relocation and to support faculty during a retention process. This office offers both relocation and dual career services. The relocation services include referrals to housing, child care, elder care and information regarding local schools. Dual career services also are available to the spouse or partner of either a newly hired faculty member or a retention case. These services include assistance with resume writing and networking.

In addition to the academic appointment they are offered, faculty consider quality of life issues, such as the availability of high quality child care and employment opportunities for their spouse or partners, in deciding which university offer to accept. Many private universities, such as Stanford and Johns Hopkins, and public universities such as Michigan, offer formal relocation programs or dual career services. There are several UC partner opportunities programs at Santa Cruz, Davis, Irvine and San Diego.

### Retiree Ambassador Opportunity with the CALcierge Office

The CALcierge Office is staffed by Lisa Bagnatori, a former geriatric social worker and Cal alumna. Ms. Bagnatori and Vice Provost Sheldon Zedeck met with the Center's Policy Board at its November meeting to discuss the role constituents might play in supporting their work.



One proposed idea is using retirees as valuable network resources for spouses or partners looking for non-academic work. For example, newly hired faculty member's accompanying spouse might be paired with a retiree who could help connect the spouse with local contacts in their professional field.

## On Campus

### Wanted for Participation in Aging Research Study

Healthy people age 70 and older are invited to participate in a study to investigate how thinking abilities change over time.

These studies are not expected to result in any medical benefit or cause you any harm. Subjects who are presently not in good health, who have had any history of neurological or psychiatric problems, or who cannot speak English proficiently should not volunteer for the study. When you call to volunteer for this study a research associate will ask you a series of questions to determine your eligibility. If you are chosen for participation, a consent form and the Subjects Bill of Rights will be given to you to read and sign on the day of the study. You will be given a verbal explanation of the protocol procedure and possible discomforts.

You will be paid \$40 for participation in this study. The study will take approximately 3-4 hours to complete.

You will come to the University of California, Berkeley, where you will have a brief medical interview and a medical examination. Following this, you will take a series of tests designed to assess your thinking abilities. These tests use pencil and paper or computers and involve things such as solving puzzles and remembering lists of words.

We will place your name on a list and contact you every 1 or 2 years and invite you back for retesting. We will also call you periodically to see if you are interested in participating in other studies in laboratories at Berkeley that are studying brain aging.

*Guest Speaker: Adrian Harris, UCLA Vice Chancellor—Planning, Emeritus*

Adrian Harris established a unified planning office at UCLA, which coordinated academic, fiscal, physical, manpower, organizational, and environmental planning. He planned his own retirement for over 25 years, which was achieved on schedule at age 59 1/2, and has maintained a thorough knowledge of University of California and Government policies and procedures.

Since his retirement he has been providing advice on estate planning and financial retirement matters to faculty and staff at UCLA, other UC campuses, and other organizations, both individually and in group sessions, as a volunteer through the UCLA Emeriti/Retirees Relations Center. He responds to generic questions in his “Ask Adrian” column run in a number of UC emeriti and retiree newsletters, concerning financial and retirement matters.

This workshop has been designed to assist individuals of all ages in personal estate and retirement planning, understanding investment opportunities and strategies, and dealing with a wide-range of fiscal and related matters. Topics to be covered include key topics for those interested in retiring soon, including leaving survivors well informed, retirement needs, how to achieve planned goals, and converting assets into life-income. Adrian does not comment on specific investments, such as stocks, mutual funds, money-market funds, etc.
