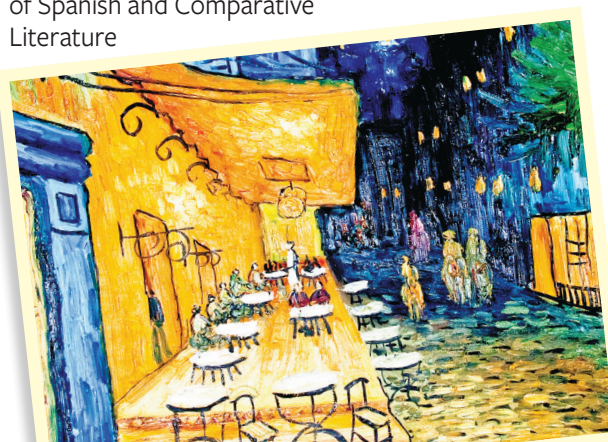

Pat "blames" her Dad for her Apple product fixation. "When the little square Mac computer

was first introduced in 1984, Dad insisted on coming up to the campus ASUC to check it out. After, we sat down upstairs in the lounge area discussing the pros and cons of buying one. At that time, it was quite an expense as I recall. But, Dad enjoyed being first on the block with the latest gadget. We did buy the Mac and never looked back. So, as you can see, I'm a chip off the old block – I love my gadgets!"

As the iPad Adventurer she is, Pat has set-up a "news feed" process using multiple applications that search for interesting articles on the internet which she shares with family and friends. Mobile devices have become Pat's "go to" technology. "I find it difficult to be without either an iPad or iPhone. Honestly, neither can my husband... it's now 'All in the Family!'" Her delight in using the iPad is certain to infuse the upcoming workshop with ways to interact with life itself through news, research, family, friends, and community.

SURVEY OF UC RETIREE ACTIVITY AND SERVICE

Heads Up! Retired staff and non-Senate academics should watch for an email inviting them to participate in an online survey to be conducted this fall that seeks to learn more about their retirement activities. This is the first time such a survey has been undertaken. It is sponsored by the Council of UC Retiree Associations (CUCRA).

The primary purpose of the short survey is to provide information that can be used by the individual campus and lab retiree associations and retiree centers to better serve and advance the interests of UC's 50,000+ retirees.

Part of the affiliation agreement includes the engagement of a planning committee of retirees and UCB campus leaders designing and planning educational and social programming for the first residents local community. It will emphasize cultural and academic enrichment along with local community involvement.
