### ***Council of University of California Retirees Association October 28-29, UCD***

UCRAB was represented by Antonia Sweet, President Lynn Bailiff, and Secretary Marian Gade. A major focus of the meeting was small group discussion of the nominating process for CUCRA officers and the development of leadership roles. Suggestions for improvement included an effort to have more personal contact among members and with the Nominating Committee as well as clearer definition of officers' duties and the time commitments involved. Some associations are also experiencing difficulty in recruiting leaders.

CUCRA and CUCEA (Council of University of California Emeriti Associations) are considering changing the meeting format to enhance productivity and reduce participation costs to campus associations. CUCRA continues to work towards a survey of all retirees with the double purpose of informing CUCRA of our interests as well as emphasizing to UC and campus administrations the importance of retiree contributions to the University and to their communities.

At the joint meeting of CUCRA and CUCEA there was further consideration of the report of the Joint Benefits Committee concerning the designation of beneficiaries of retirement savings accounts: naming a will or trust as beneficiary may trigger unexpected tax problems. All retirees should check with their legal counsel or with Fidelity to ensure that beneficiaries are listed correctly.

The Director and Manager of RASC (Retirement Administration Service Center) reported the satisfaction rate for service from RASC at 85% satisfied. Although it will not affect current employees or retirees, there was a report on the progress of the task force on the creation of a new retirement tier for employees hired after July 1, 2016. There will be no major changes to medical plans for 2016; Open Enrollment closes on Nov. 24, 2015.
