## Special Thanks to Adrian Kragen

Adrian Kragen, Professor of Law Emeritus, played a crucial role in founding the Center and securing its space in Boalt Hall. On April 1, we say thank you by naming our conference room in his honor.

Kragen first came to Cal as an undergraduate in 1927. He graduated summa cum laude in 1931 and, after a brief time at Hastings, returned to Berkeley to finish his law degree. After practicing law for several years, Kragen became Assistant Attorney General for the State of California ('40-'44). He then returned to Cal as the Shannon Cecil Turner Professor of Law until his first retirement in 1973. Retirement, however, did not last long. Kragen taught at Hastings from 1973-1980 and again at Cal from 1980-1994.

Today, in addition to his participation in the Retirement Center, Kragen still actively supports and participates in Boalt Hall School of Law and Cal Athletics.

Shelley Glazer, M.S.W., M.P.H., is Director of the Retirement Center. A second generation graduate of UCLA and Cal, Glazer has worked in the field of gerontology for almost 20 years.

# Center Makes Campus Services Available to Emeriti and Retirees

The Center has arranged to extend three campus services to you:

**International Travel Care.** Through this service, you can get a personally tailored health and information package based on your itinerary, health history, and planned activities. Immunizations are available, as well as a computerized traveler's report. There is a charge for this program. A free information session will be conducted by the Travel Care Medical Staff. **Free Hours at the Berkeley Art Museum.** Emeriti and Retirees are now eligible for free entrance to the Berkeley Art Museum on any Thursday between noon and 5 p.m. Just show your Retiree ID Card.

**Returning Student Orientation for Retirees.** Ever think about returning to school? The Retirement Center is in Room 2, Boalt Hall. Boalt Hall is located on Bancroft Ave., between Piedmont and College Avenues. Room 2 is located on the ground floor, in the Southwest corner of the building just off the fountain plaza.

#### By BART:

Take BART to the Berkeley Station. Exit the station and proceed to the bus stop in front of Bank of America. Catch a *UCB Perimeter Shuttle*, which will take you clockwise around the campus. Get off at College/Bancroft in front of the Fountain. The bus will cost \$0.25.

## By bus:

AC Transit bus lines 7, 51, 52L, 604, and 605 stop at Bancroft and College. Bus lines 40, 40L, and 64 stop 3 blocks away at Telegraph and Bancroft.
