Nobel Laureate Charles H. Townes

Professor in the Graduate School, Department of Physics

UCRAB is very proud to present one of the most eminent scientist of our time as its speaker for the summer luncheon on June 11 at the Berkeley City Club. Professor Charles H. Townes won the Nobel Prize in Physics in 1964. Townes is best known for his work in the field of quantum electronics, which led to the invention of the laser, surely one of the 20th century's most important scientific achievements. He will speak to us about his ground-breaking work on the laser, and maybe we'll finally understand how it works.

At the age of 94, Professor Townes is still actively engaged in research at the Space Sciences Laboratory at Cal. In fact, his assistant told me that she can't keep up with him. President's Message

Iola James's column is absent, as she is recovering from surgery. All indications are that her recovery is going well. The column will return in the fall 2009 issue.

Report from UCRS - February, 2009

The Regents approved the following items at their February 2009 meeting:

- 1. Contributions to the UC Retirement System will be reinstated on or about April 15, 2010. In fiscal year 2010 the University contribution will be 4% and will be at least that much in FY 2010/2011. The employee contribution for the same period will be the same as the rates currently redirected to the DC Plan, subject to collective bargaining when applicable.
- 2. The new policy on the reemployment of retired employees into Senior Management Group and staff positions, effective January 1, 2009, changed to include retired academic appointees as well. However, it does not apply to recalled faculty teaching or research appointments.

The Constitutional Amendment Initiative 1349 which would create a separate Board of Trustees with sole jurisdiction over retirement funds needs approximately 690,000 signatures by June 22nd in order to qualify for the June 10, 2010 ballot.

In February the Office of the President's Human Resources and Benefits unit mailed the 2009 Personalized Retirement Update and Readiness Guide to active UCRP members and rehired retirees.

The Worker, Retiree, and Employer Recovery Act of 2008 signed into law on December 23, 2008 contains a provision for a one-year suspension of the IRS regulation governing Minimum Required Distributions (MRD's) from retirement plans such as UC's 403(b), 457(b), and DC Plans. All UC participants in the plans who are 70 ½ or older in 2009 should have received an announcement from Human Resources and Benefits in February.
