# "Some Baseball Poems: A Talk by Baseball and Poetry Buff Lewis Rubman, PhD"

In his June talk, Lewis Rubman will comment on three baseball poems—two from authors in baseball-loving countries outside the United States. Japanese poet, Haruki Kadokawa wrote "Lights-out Siren" and Nicolás Guillén, the Poet Laureate of Revolutionary Cuba, penned "Elegy to Martín Dihigo." Rubman will also include Richard Jackson's "Center Field."

Lewis entered UC Berkeley's graduate program in Spanish in 1963. Last December, just 48 years later, he completed his doctorate in Comparative Literature following his retirement from the Alameda County Social Services Agency. He incorporated his passion for baseball into his literary studies titling his dissertation *On the Poetry of Baseball*.

Lewis and his wife Gail have been avid A's fans for years and travel frequently to ball games throughout the Greater Bay Area, the U.S. and the world.

# May 2012 UCRS Report

The Governor's pension reform proposals are of great interest to UCRS. To pass the Legislature it will take a two-thirds vote of both houses, then a majority of votes in a statewide general election will be necessary to complete the process. Some of the provisions will apply only to those hired as of July 1, 2013 while others would apply to current employees as well. They will not apply to retirees.

### Visiting the New Bay Bridge

### **Up Close and Personal**

This spring the Learning in Retirement Program offered an outstanding course on the new eastern span of the Bay Bridge. On the last day of the course, 75 of us met near the toll plaza and were divided into three groups. While one group enjoyed an overview with video lecture detailing the plans, manufacture, assembly and installation of the parts for the new span, another group went via a small bus onto the new span and the east end of the cable portion. The third group traveled by boat to observe the new span from the water level.

We observed the workmen stringing rods up over the tower, down around the saddle back, back up over the tower and down to the anchorage. When compressed together, the rods will form the cable and will be anchored at the east end of the new span.

On our way to the boat we passed the Left Coast Lifter, a \$50 million crane built specifically for the bridge construction. A small harbor boat took us out on the Bay where we saw temporary structures supporting the new span and large cylinders which tie together the span sections. I lost my hard hat in the Bay while looking up at the 'nesting' facilities that will allow birds who now nest in the ironworks of the original span to nest in the new span.

The new span will open Labor Day Weekend, 2013. Thank you Learning in Retirement and UCB Retirement Center for the unique opportunity to tour this most important Bay Area bridge.

# Spring CUCRA Report

The statewide organizations of UC retirees (CUCRA) and emeriti (CUCEA) met on April 26-27; attending were UCRAB President Iola James, CUCRA Rep. Allan Jensen, and myself (also chair of CUCRA).

Highlights included a discussion of UC President Yudof's recent acknowledgement that retiree organizations are an integral part of the UC family and eligible to participate in UC-sponsored liability insurance programs. CUCRA's Bylaws and Standing Rules were reviewed with a key addition being the formal recognition of the long-standing Joint Benefits Committee (JBC), a group appointed by CUCRA and CUCEA to consider, and make recommendations regarding, pension and health problems and benefits for UC retirees.

Debora Obley, UC Associate Vice President, Budget and Capital Resources, candidly reviewed the University's budgetary problems. She pointed out that Governor Brown's proposed ballot initiative would benefit the University indirectly, despite the fact that it is not specifically targeted for any of the revenue. However, it will help the ongoing structural deficit that California has been contending with for more than a decade. UC can't move forward until the State actually resolves that issue.
