### **President's Message**

Since the last newsletter, UCRAB has had two successful events which will be detailed elsewhere in this newsletter. First was a successful outing to Rincon Annex to see the murals painted during the New Deal, followed by a dim sum lunch. The second was Cal Day where a number of retirees volunteered.

As I have stated in past messages, UCRAB continues to monitor issues related to benefits and to advocate on your behalf where necessary. The Retirement Administration Service Center (RASC) continues to experience delays when processing retirement applications and survivor benefits. As to the latter, they have recently created a unique phone number and a specially trained team to handle survivor benefit issues. Anecdotal reports indicate things are better. We have been told 2023 retirement applications are being processed quickly due to the increased confidence in the computer application. The Council of UC Retiree Associations (of which UCRAB is a member) and the Council of UC Emeriti Associations continue to press UCOP to bring back individualized retirement counseling to the campuses. There appears to be

movement in this regard. In addition, Cheryl Lloyd, Associate Vice President of Human Resources at UCOP, has agreed to appoint a standing committee of retirees to advise her and her staff on issues raised by retirees, including health and retirement benefits.

## Elections

At-large Director--Sue Gettinger: Sue worked at Berkeley for 11 years in the College of Chemistry after spending 32 years in the laboratory glassware field, and retired in 2014. After retiring, she joined UCRAB and in 2019 assumed the task of organizing and coordinating the UCRAB luncheons, trips and special events. At-large Director--Alma Valencia Gross: Alma is a Cal Alum. After starting in the private sector, she returned to UC Berkeley and a 42-year career at the campus. She retired in 2017 as the Senior Associate Director for Environment, Health & Safety and also joined UCRAB. Prior to EH&S, she held various analyst roles at Campus HR (14 yrs) and was a project director (3 yrs) for the Chancellor's Office on a major campus biosciences reorganization project. She is currently on the board.

#### **UCRAB – Out and About**

As mentioned earlier, UCRAB had two successful events since the last newsletter.

The first was a trip to **Rincon Annex** (the old post office in San Francisco.) 25 retirees and guests arrived in downtown San Francisco via BART or ferry. We met up with Dr. Gray Brechin, a graduate of Berkeley and the Director of the Living New Deal Project. He first described the exterior of the building which was built in the 1940s. Inside, the 27 murals painted by Anton Refregier detail the history of California and were extremely controversial when they were painted for a variety of reasons. They have survived multiple attempts to remove them over the years. We encourage others to take a peek at them when you are in downtown San Francisco or do a Google search to find out more about them. After the tour, about half of the group had lunch at Yank Sin, a dim sum restaurant in the annex. It was interesting ordering dim sum with people we did not know, and although there was disappointment by some that they didn't get their favorite dishes, it was all delicious and fun to meet fellow retirees.



The second event was **Cal Day**, held on April 22. About 25 retirees joined the Cal student ambassadors in welcoming new admits and their families to the campus. Some helped with seating at Memorial Stadium early in the morning for the Chancellor's welcome. Others manned information booths at various locations around campus. And still others helped out at the Campanile, monitoring the lines, answering questions up on the Observation

## **CUCRA-CUCEA Update**

Twice a year, the Council of UC Retiree
Associations (CUCRA) and the Council of UC
Emeriti Associations (CUCEA) meet to hear about
what is happening at Office of the President relating
to retirees; to get updates on current and future
retiree benefits; and to share information and
experiences at the campuses and the National Labs.
In April, the Zoom meeting was hosted by the Santa
Barbara campus.

On the first morning, both organizations met and were welcomed by **Chancellor Yang**. This was followed by a Q & A with Vice President of Human Resources, **Cheryl Lloyd**; Associate Vice President of Total Rewards, **Jay Henderson**; and Executive Director of RASC (Retirement Administration

Service Center), **Bernadette Green**. They answered questions regarding their organizations, especially the challenges with RASC. Many of these challenges go back to the implementation of a new computer application which did not work as promised and has taken several years to achieve some of the functionality that was promised. There are still a number of issues to address regarding customer service and delays. There will most likely be no changes to health plans next year and modest price increases.

An important report each meeting is the one from the Joint Benefits Committee, which can be found here. The intent of this report is to outline important issues/concerns that need to be addressed by the Office of the President. In the latest report, 4 major areas were addressed: RASC, VIA Benefits (which provides health insurance to retirees living out of state), Delta Dental Issues, and an Advisory Committee to address concerns of retirees. There was a lively discussion surrounding these issues.

The last item at the joint meeting was a report on the Retiree Travel Program, which sponsors about 12 trips per year. The program earns money based on the number of travelers on the trips; in 2022 it brought in over \$30,000. The funds will help defray the costs of the biannual meetings and offset the CUCRA dues paid by the campus associations.

CUCRA met the following day. In addition to discussing issues affecting CUCRA members which were raised at the joint meeting, the Treasurer reported on the finances, the recent audit, and the completion of recent successful applications to the IRS and the State Franchise Tax Board for tax exempt status. The rest of the meeting was devoted to a conversation with representatives on how CUCRA can better engage with campus associations.

The October meeting will be hosted by UC Davis, and as an experiment, it will be a hybrid meeting, i.e. in person and via Zoom.
