

Retirement Then and Now Russ Ellis

Professor Emeritus William Russell Ellis, known to everyone as "Russ," will be the guest speaker at UCRAB's Fall Luncheon. Russ's affiliation with the Berkeley campus began in 1970, when he joined the faculty of the Architecture Department. Since that time, his personal warmth and dedicated service to Cal have made him one of the most beloved members of the campus community.

As a professor, Russ studied and taught about social and cultural issues as related to architecture and urban design. In 1990 he was appointed Vice Chancellor for Undergraduate Affairs, where he led campus efforts to improve the quality of undergraduate education and to make the undergraduate student body more reflective of California's diverse population. Russ has said that one of his proudest achievements as Vice Chancellor was



collaborating with Maryellen Himmel in developing the Incentive Award Program that helps give talented low-income students better access to Cal. Russ also served as Director of the Institute for the Study of Social Change, a research center dedicated to understanding the processes of social change and contributing to the transformation of conditions of inequality. He was awarded the Berkeley Citation in 1994.

Russ grew up in Southern California, went to Compton High School, and attended UCLA on an athletic scholarship. (He ran the 440-yard dash and just missed qualifying for the 1956 US Olympic Team in the 400-meter dash.) He earned his Ph.D. in Sociology at UCLA and taught at the Claremont Colleges and in the State University of New York System before coming to Cal.

At present, Russ is one of twelve seniors whose careers and current activities are on view in a photo exhibition in the gallery at the Ashby Village office in Berkeley. Russ says: "In my painting and sculpture, my goal is to contribute to this extra-verbal world that is the world of art. People who got their art degrees and are well educated are obliged to make words. But they also know about that aspect of the human consciousness and interchange that's about images, not words. So images are what I'm working with right now."

University of California Retirement System Advisory Board

The UCRS Advisory Board met on June 23 at the Office of the President in Oakland. The COLA beginning July 1, 2017 was 2%, based on the average increase in the Consumer Price Index. For those who retired after July 1, 2006 please refer to the table in the May edition of "New Dimensions." The increase in your benefits was paid at the end of July Purchasing power is kept at 75%.

In July an item appeared on the Regents' Meeting agenda regarding a plan to change the basis of the Regents' contribution to health insurance plans, eliminating the current 70% amount, but not stipulating a new percentage. This item was subsequently postponed until the November Regents' meeting following protests from retiree associations over lack of consultation on this issue. UCRAB President Lynn Bailiff wrote Lynn Bailiff wrote UCRAB members on July 26 regarding this issue.
