CUCRA/CUCEA MEETING at Berkeley, October 24 - 25, 2018

The joint meeting of the Council of UC Retirees Associations and the Council of UC Emeriti Associations took place at the Doubletree Hotel in the Berkeley Marina. The sponsors were the UC Berkeley Retirees Association and the Emeriti Association, the Excels and PARRA.

Associate Vice Provost at UC Berkeley Angelica Stacey welcomed the participating members to the meeting. The minutes from the April meeting were approved and the announcement was made by Prof. Harry Powell that the Spring 2019 meetings will take place on the UC San Diego Campus on April 24th and 25th, 2019. A report regarding the work of the Retiree Health Insurance Design Working Group was presented by Roger Anderson, emeritus from UCSC, and John Meyer, staff member from UCD. The University has brought in consultants. The working group will continue for another year.

An announcement was made that because of a bomb scare at the Office of the President Michael Brown, Provost at UCOP and Rachael Nava, Chief of Staff for President Napolitano would not be able to participate in the meeting because they could not leave their building. Therefore, there was no report on the UCOP generated Huron Report which was generated by the consulting company as a result of the audit that looked at UCOP operations.

Professor Anderson is also the Chair of the Joint Benefits Committee, made up of eleven members representing emeriti and retired staff from the various campuses. The report addressed pensions missed, MRDs, health plans report to the Regents, and updates on the Year End Report and the law suit involving the Livermore Retirees vs. the Livermore Laboratory.

Redwood, the new retirement data system, will be up and running in February 2019. Michael Waldman will be the RASC contact for Redwood. UCPATH uses The Work Number, a division of Equifax for employment and income verifications.

CUCRA held its meeting on the morning of April 25. Changes to the By-Laws which had been tabled in April were brought forward for a vote. A few new word changes were discussed and then approved. After a discussion it was decided not to change the Standing Rules at this time.

The new AROHE (Association of Retirement Organizations in Higher Education) Innovation Award was given to the CUCRA Survey, UC Retirees, Advocates, Ambassadors, Assets. The trophy was displayed amid congratulations to the Survey Committee. There was a discussion which emphasized the importance of doing the survey every three years and the importance of getting it to the Regents. A new committee will be chosen by June 2019 to begin the work of planning the next survey.

The next CUCRA meeting will be held at the UC San Diego Campus on April 24 and 25, 2019.

The wonderful trips that Iola organized for UCRAB are a special way to remember herovernights at Yosemite or the Reno Snow Trip and day trips to the Monterey Bay Aquarium or the Filoli Gardens. She was very creative in finding delightful excursions and was dedicated to ensuring that every participant had a good time.

Iola's long service in the Dean's Office of the College of Engineering and her understanding of the Berkeley campus were the perfect preparation for leading UCRAB. While serving as Board President from 2008 to 2014, Iola opened new directions for the Board and UCRAB's general membership. As President, she was also deeply involved with the campus Retirement Center Advisory Board, the Council of UC Retiree Associations, the Association of Retirement Organizations in Higher Education, and the Chancellor's Receptions for new retirees.



One of Iola's proudest achievements was the establishment of a UCRAB scholarship fund to support low-income students attending local colleges. Each year, a portion of the price UCRAB members pay to attend the Day at the Races is put in this fund and supplemented by other funds raised by UCRAB. The UCRAB Board has decided that this year's donation to the East Bay College Fund will be in Iola's memory. (Information about the Fund appears in this newsletter.)

Iola's family noted in its remembrance that she loved music, dance, and art, training as an operatic singer with performances all around the Bay Area. These interests and accomplishments are yet another dimension of a unique individual who was known for her grace and personal warmth.

EAST BAY COLLEGE FUND

The mission of the East Bay College Fund is helping resilient public school students from groups underrepresented in higher education to access and succeed in higher education. The Fund not only provides four-year scholarships to low-income, first-generation scholars but also offers guidance and encouragement through its professional staff, mentors, and experienced students at the scholar's college. To date, the Fund has supported 1,142 graduates of Oakland public with a six-year graduation rate of 80%--four times the national rate for students in their peer group.
